

## David vs Goliath

A line in the sand was drawn October 2016 by CHEER Founding President Herman Garcia at the intersection of Watsonville Rd. and Redwood Retreat Rd. This area is also the confluence of "Little Arthur" creek and Uvas Creek. "Lil Art" is the top producer of Steelhead Trout in the Pajaro River Watershed. The Uvas Creek sub-basin

provides the drinking water for Gilroy and is the major migration route for Steelhead once they enter south county from the Pajaro River. There are 9 tributaries to Uvas Creek which provide precious spawning gravel. PG&E proposes to build a substation at this location which prompted the attack and challenge by Garcia at a public forum at Fortino Winery in front of 200 rural residents. 'This is the most sensitive area in the watershed, what are you thinking?" demanded Garcia to thunderous applause from an overflowing crowd.......cont'd page 7

Winter flooding of 2016 closes Thousand Trails Park in Morgan Hill. Located on Uvas Rd one mile downstream of Uvas Dam on Uvas Creek at the base of the Santa Cruz mountains. The severe winter caught everyone by surprise with CHEER's Gilroy rain gauge topping out at 39 inches of rain for the winter and Summit Rd. above Los Gatos measuring 105 inches.

Thousand Trails suffered major damage resulting in park evacuation and closure. The park's main bridge was completely blown out and would have to be replaced before the park can be reopened. The park owns approx. 1/2 mile of stream channel. Post flooding left the channel littered with flood debris. The plan was to assist park management with creek cleanup.

Every year Gavilan college Environmental students team up with CHEER volunteers to restore local creeks in need of cleanup. Park Officials provided a greatly appreciated lunch for tired and hungry volunteers.





## **CARS VANISH!!!**

## **EROSION**



Uvas Creek rose to it's highest level since the 1980's. With flows topping over the banks in some area's causing major damage to Santa Clara and San Benito counties. Historically, land owners would anchor automobile bodies (minus engines/trans) to river banks for erosion protection. Such a location still existed until the recent flood blew out the anchors and caused massive bank failure!

The location is on Uvas Creek south of Gilroy on Old Bolsa Rd. approx. 8 cars were placed to secure the bank nearly 60 years ago. With the anchor failure 4-5 cars have DISAPPEARED being washed down stream. As is customary CHEER will eventually discover the car bodies and remove them. As a reminder, CHEER removed 6 autos abandoned in the Pajaro River last year and 5 boats the year before.

"You don't know what you are stepping into" he said after listing endangered and threatened species from Bald Eagles to Steelhead. And then citing a past case of a local wealthy resident who killed a dozen Steelhead and ending up broke and in Federal Prison, he had this to say to PG&E. "You can't beat me, I will destroy you if you ever consider putting a shovel in the ground, you mess with our protected resources you are going to fight the U.S. Attorney General's Office". CHEER soon



Attorney Bruce Tichinin to defend our natural resources. With a successful defense, a resolution was provided to Santa Clara county supervisors. PG&E has stepped back, but we must remain vigilant and prepared to battle this threat if it re-emerges.
